c. HORSE SUPERINTENDENT'S REPORT (Ann/Jeanne/Kaileigh)

FAIR TRAIN – A “train” (a golf cart with 3 carts behind it) will be present at the 2025 CCF. This train will go up and down the midway and will turn into the horse area near the expo hall, hug the chain link fence, and leave out the gate that says “No Horses Beyond this Point”. Kailiegh has relayed safety concerns to the fair manager. She was told that it is quiet, no louder than the gators or steam engines, and that they will turn off all of the bells and whistles before coming down into the horse area. Confirmation and specifics will be provided as is known.

CCF ENTRY FORMS AND HORSE CERTIFICATES – ALL Clark County Fair entry forms and Horse Certificates will be entered in 4-H On-line. This is the same system that was used last year to sign up for state fair. The 4-H office is currently receiving training on this process and we will receive training afterwards.

Horse Certificates are available to enter on-line now.

Ann suggests putting both the horse's registered name and barn name in the horse's name section.

Deadline for Horse Certificates remains 5/1 as always.

Entering Horse Certificates this way attaches the horse to a member. Multiple horses can be entered for an individual member.

It is unknown at this time whether leaders will have the ability to create reports or otherwise look into whether their members have submitted appropriate Horse Certificates or fair entry forms.

For fair entry forms, a few things will be different. When completing, you will choose the member's name, choose their age division, and then there will be a drop-down box for classes. Ann will bring a paper copy of the classes or provide one by e-mail for leaders to take to their clubs to go over with all members. Members can then take their pre-filled paper with them home to ensure they fill out the appropriate information and classes they want to enter.

For those attending state, all information will be in the system already, so there will be no need for a state meeting to register members.

Ann will have the ability to make changes at fair, i.e. scratching classes, change of horse, etc.

The DRAFT HORSES are adding the last Friday at noon to their show schedule. It is unknown if it will be held in the inside or outside arena.
