- c. **Black Pearl Halloween Show Trail Sign-up** – Trail Course Sign Up: 4-H Horse Leader's Association agreed to set up and man the 2025 haunted trail course prior to fair. - d. **Clark County Saddle Club (CCSC) Rodeo** will occur July 10 – 12. The facility cannot yet handle rough stock, but there will likely be a junior rodeo and speed events. CCSC is also working on making a permanent trail around the 40-acre CCSC property with built-in and permanent trail elements. This would be open to the public. - f. It was noted that Jessica wants to include jumping on Dressage and Horse Judging day at the 2026 CCF.
